



# Sliding Scale Dues 2021-2022

## How are dues computed?

Dues are computed based on your salary and whether you are a full- or part-time employee. The total dues include EASMC, MSEA, and NEA dues. The chart below shows the current combined dues per year and per pay. Your dues will be automatically adjusted if your salary or PT/FT status changes. Annual dues are subject to periodic changes by their governing bodies. Your authorization continues from year to year unless you revoke the authorization as specified in your negotiated agreement.

## Am I a certificated or non-certificated employee?

If your current SMCPS assignment requires a state certificate or equivalent, then you are classified as a certificated employee. Examples include teachers, counselors, nurses, and speech pathologists.
