

## REPRESENTATIVE ASSEMBLY



- The Representative Assembly voted to approve the EASMC FY26 Budget, as recommended by the Budget Committee. Great news - local EASMC dues remain the same! Send questions to: easmctreasurer@mseanea.org.
- The Board of County Commissioners have agreed to fund SMCPS \$3.1M over the originally planned flat-funding. This increase will support the funding of the negotiated agreements and pay raises within. Union advocacy for the win!

#### TENURED RESIGNATIONS

If you were tenured as of the beginning of the 2024-2025 school year, then you are obligated to give notice by July 15 if you will not be returning next year. As of July 16, 2025, teachers who are nontenure (based on the 2024-2025 school year) are officially considered to be under contract for the 2025-2026 school year. If leaving the school system with tenure, then you must disclose that to SMCPS by July 15, 2025. As a tenured teacher, SMCPS cannot simply give notice that your annual contract is not being renewed; it must pursue a termination with cause, which is an entire process dictated by both the negotiated agreement and COMAR.
